

End of year message



John Davidson, Chairman, N.I. Federation of Clubs

That was quite a year, and the problems are still present and have still to be overcome.

With the pandemic came the financial problems which impacted on the entire hospitality sector. Despite the promises of help, which may have been well intended, the delay in getting that support released was disappointing.

We were pleased to assist quite a number of our sector members who fell short of compliance during the first support package, which required us to challenge the fairness in the support and the way in which it was structured.

Eventually a further support package was created which proved helpful, but not everyone was in a position to benefit. However, through support of a twelve month rate free period, and the furlough scheme, we have battled on and will hopefully see the sector open on December 11th.

Many clubs contacted us seeking advice on holding their club AGM, which require contacting the Federation Solicitor who advised that it was acceptable to follow Government Covid-19 guidelines. Naturally, it would have been preferred to hold an AGM, however common sense and the aforesaid Government

advice led everyone to adopt caution. Indeed, many will be aware that the Federation AGM was to be held on day one of the first lockdown!

The Federation continue to work remotely, conducting business via Zoom and telephone.

This method of communication will again be adopted when we meet the Communities Minister, the Assembly Committee, a meeting on the Entertainments License Consultation, and a meeting with officials and the PSNI on the Accounts regulations pertaining to registered clubs.

In relation to the aforementioned, members can feel reassured that we remain active in pursuance of fair legislation for the registered club sector; legislation which has gone unaddressed for far too long! We have continually asked the question, 'why do the accounts regulations need to be prescribed, rather than being similar to those afforded to other business sectors'?

'Why are registered clubs restricted in the number of late extensions available to them, particularly when they cater for an age group less likely to create anti-social behaviour'?

'Why have registered clubs been prevented from placing notices in the press'? While some of these issues are likely to be addressed in the Licensing Amendment Bill, a number are less likely to be forthcoming.


Nevertheless, we survived the 2008 financial crisis, so hopefully we can overcome this to reach better times. With all the necessary equipment already in place, we are in a good position to adhere to good practice to protect our members, guests and staff alike.

I feel it important to recognise the outstanding way our suppliers have stood by us during this difficult time. Our established associations have been in place for some years, and I would ask our members to reciprocate the support they have provided. The Federation will certainly not forget it, as it was forthcoming at a time of great uncertainty.

Update on amendments to NI Licensing Bill

Dear Secretary,

With the Northern Ireland Licensing Amendment bill having recently reached the second stage at the Northern Ireland Assembly, we thought it important to inform you that we have been invited to address the Assembly Communities Committee and to meet the Communities Minister in early December 2020.

Please be reassured that your Federation has been working tirelessly over recent months, and in earlier years, to bring the Registered Clubs Legislation, including the Accounts Regulations, into a more acceptable, appropriate and suitable format.

These are times we are unlikely to see again in our lifetime, and it is our sincere hope that all our sector members, and suppliers alike, will come through this to better times in the not too distant future.

The following details outline those issues we are satisfied as having secured, and those we are unhappy with and wish to focus our energy upon.

- a) The requirement for Childrens Certificates will be removed, allowing children on all club premises until 10pm.
- b) A clubs registration to provide alohol will be permitted to extend their area to include sports grounds, six times per year, with an

- application of this kind being available to cover a period of one to six days. This could be utilised for a range of events, such as those related to sport and concerts etc.
- c) At long last the restriction on advertising will be removed but with 'Members and Guests' highlighted in advertising copy, unless it is for a charity event, in which case the advertisement will not be subject to such restrictions.
- d) Late extensions to remain at 85 per year.
- e) Young people to be permitted on sports club premises until 11pm during June, July and August.
- f) Restrictions on Easter opening hours to be abolished.
- g) Drinking-up time to be extended by 30 minutes to provide one hour.



Latest update on gaming machine VAT case

As most clubs will be aware, HMRC conceded defeat earlier this year in the longstanding litigation with Rank Group Plc in respect of VAT paid to HMRC incorrectly, and at HMRC's insistence, on gaming machines operated by Rank prior to December 6, 2005.

HMRC published a Revenue & Customs Brief 5 (2020) setting out HMRC's position and inviting all taxpayers who considered they had a valid claim for repayment for such VAT to make application for its repayment. HMRC set out a list of information they consider they require to validate a claim in Brief 5 (2020).

Brief 5 (2020) makes clear that any taxpayer with a valid claim and a valid appeal will be repaid as soon as HMRC have undertaken the checks they need to make and authorised the claim, but HMRC expect any taxpayer who thinks they have a valid claim to contact HMRC.

It is insufficient, having originally been paid by HMRC in 2010/2011 and subsequently recovered by HMRC in 2014, to expect HMRC to repay the monies without making such an application.

In addition, we have recently been made aware that the opportunity to recover these monies may soon disappear, as after January 1st 2021 when the UK leaves the EU, the UK will no longer be obliged to act according to principles set out by EU legislation, and in this instance the principal of fiscal neutrality (i.e. treating each taxpayer in an identical manner) may no longer be observed by the UK government.

Initial observations indicate that HMRC are rejecting some claims as having no valid appeal on the basis that there is no appeal against the protective assessment, which is a requirement set out in an earlier Tribunal hearing. What HMRC seemingly fail to mention is that any person in this position can make application to the Tribunal to join an appeal against the protective assessment to the earlier Tribunal appeal.

HMRC require a letter to be sent to HM Courts and Tribunals Service (copied to HMRC solicitors office) requesting that this happen, and where possible, with a copy of the protective assessment.

Other reasons where HMRC have been seen to reject



applications for payment, are where original appeals were mistakenly withdrawn, no appeal was made at the time soon after the claim was initially made as there was no notice of rejection from HMRC or a valid claim was not originally submitted. It may be possible, subject to the individual circumstances of each claimant, to resurrect an appeal or a claim.

To conclude, clubs need to

- 1. During 2007 did they or the club auditor apply to HMRC to be refunded VAT on gaming machine monies for the period 1st October 2002 to 5th December 2005?
- 2. Did the club successfully receive this vat refund from HMRC?

3. Did the club have to repay this vat refund plus interest to HMRC around 2010 or 2011?

If the answers to the above questions is YES, then the club should be entitled to apply via the Tax Tribunals Service to get HMRC to repay this money, plus interest.



Questions & Answers

Q. Can you let us know if an employee is able to work alone inside the Club? Our cleaner works on her own in the morning prior to the Club opening.

A. I can confirm that it is perfectly legal to allow an employee to work alone and that in many Clubs the Club's cleaner will



on their own simply because of when the cleaning takes place. Having said that, the Club does have a duty of care to its employees and if any employee is concerned about working on their own then such concerns should be appropriately addressed by the Committee. In any event, it would be worth performing a risk assessment to assess if there are any inherent risks for an employee working alone (a cellar door which could inadvertently lock an employee inside for instance).

Q. The Committee has recently questioned if the Club should have a formal 'whistleblowing' procedure in place for employees wishing to report something which is wrong. Do you have any advice as to how such a policy could be formed?

A. I am not aware of a Club which actually has in place a specific 'whistle-blowing procedure'. I would suggest that a Member of the Committee, possibly the Club's Secretary, is simply appointed as a point of contact for the Club's employees. The Club's employees should then be encouraged to speak to the appointed contact person regarding any issues which have arisen or problems which they have.

Q. A member of our club recently attempted to purchase a beer so that a shandy could be made for an underage Member of their family. In this instance, the Club's bar staff refused to sell the Member the drink as they knew what it was intended for. Is it correct that a diluted beer, such as a shandy, is still

unlawful to serve to a person aged under 18?

A. It is indeed unlawful to serve any drink which contains alcohol to a minor and your bar staff were correct to refuse the sale once they knew what the Member was intending. The only exceptions to the law preventing alcohol sales to persons under 18 are for aged 16 or 17 when purchasing a drink with a meal (is the meal is to be consumed in an area specifically set aside for food) or a product which contains 0.5% alcohol or less which can be legally sold to anyone. However, the Committee may wish to instruct bar staff to simply not serve alcohol to anyone under 18 irrespective of these allowances to make sure any appearance of impropriety is avoided.

Q. We had an incident inside the club and as a result the police were called. After taking statements from the parties involved the police have decided to take no action. Several members of the committee feel that the member involved should face a disciplinary hearing; can we take disciplinary action against a member if the police have already decided that they will not prosecute the member?

A. The committee are not bound by the decision of the police not to prosecute. The police base a decision to prosecute or not to prosecute on a number of factors and a decision not to prosecute does not necessarily mean that the person is not guilty of the allegation. The committee can hold a disciplinary meeting and review the allegations and make their own decision regarding what, if any, action is required under the terms of the club's rules.

Q. We have a car park which is intended for Club Members only. We frequently have nonmembers using the car park. Is there anything we can do to prevent this behaviour?

A. There are a number of ways to deal with cars which are parking without authorisation in the Club's car park.

One of the most effective ways is to simply install a physical barrier, although this is not practical for every Club.

Alternatively, pursuing parking invoices through civil action can be very effective. If the correct documentation is affixed to the car park then a Parking Charge Notice can be affixed to cars parked in the car park without authorisation. These notices will inform users of the car park that a fee will be charged if the car does not have the authorisation to park in the car park. If the person, once issued with the notice, does not

send payment then the Club can simply pursue this matter through the Small Claims Court.

I suggest obtaining clear photographic evidence of the car parked and the signs which indicate that the charge notice will be issued and the level of which the charge has been set at. This documentation will assist with any resulting legal claim. You will need to place signs in the car park stating the cost of unauthorised parking and then attach a notice to any cars which use the car park without authorisation stating that they have to now pay this cost to the Club otherwise legal action will be taken to enforce payment. Essentially, by parking in the Club's private car park it will be considered, if proper notices have been displayed in the car park, that they have entered into a contract with the Club and will therefore pay the agreed rate listed on the car park signs. There are also third party companies which will deal with this type of enforcement on the behalf of the Club although we have no direct experience of these companies.

Another month, another change in coronavirus legislation



In November the Government announced that the furlough scheme (CJRS) was to be extended until March 31st 2021. This means that the Job Support Scheme and the Job Retention Bonus (and our previous guidance) is currently on hold. We are unsure if the Government is planning on re-introducing both schemes next year, but it could be that they are replaced with another incentive.

Until 31st December 2020, the Government will pay 80% of an employee's wage whilst furloughed with employers paying pension contributions as well as NIC's. It is likely that the Government will increase employer contributions whilst dropping their own contributions come January 2021, however, no official guidance has been released as of yet. It is expected we will know more before the end of December to enable a swift transition onto the new contribution requirements.

There are some things worth noting when it comes to the reintroduction of the CIRS:

- You do not need to have used the furlough scheme before to use this scheme
- Flexible furlough still applies if you can offer part time working

- Employees who have previously been furloughed continue to have their reference pay and hours based on the existing furlough calculations (the same as those under the old scheme).
- For those employees who have not previously been furloughed it appears that the pay is based on 80% of the wages payable in the last pay period ending on or before 30th October 2020 (for those on fixed wages).
- For those employees on variable wages, it appears that the pay is based on 80% of the average payable between the start of their employment or 6th April 2020 (whichever is later) and the day before their CJRS extension furlough period begins.
- Those shielding in line with public health guidance or those who need to stay at home with someone who is shielding can be furloughed
- Employees that were employed and on the payroll on 23rd September 2020 who were made redundant or stopped working for their

employer after that date can be re-employed and claimed for if appropriate.

An importance difference between the CJRS this time round is that for claim periods that start on or after December 1st 2020, you will not be able to claim for any days after this date where your employees are serving a contractual or statutory notice period (or have resigned and are serving notice).

You will also need to make an adjustment if an employee starts a period of notice and any days cross into the period after December 1st 2020.

Previously, you were able to see out the entire notice period whilst on furlough (albeit potentially at 100% pay).

It appears that this change is an attempt to deter redundancies further.

I would like to thank Cameron and all the members of REC-IT for the wonderful work they do and the times we have shared at Belfast 89FM.



Education Minister praises Ulster GAA and IFA sports programme

Ulster GAA, in partnership with Irish Football Association (IFA), recently delivered a school sports programme aimed at encouraging a love of sport and increasing emotional resilience for young pupils.

The programme, focusing on pupils aged 7 to 11, promoted the benefits of participating in sport and physical activity and encouraged pupils to develop a lifelong interest in maintaining an active and healthy lifestyle.

It is also designed to help students increase their emotional resilience with a particular focus on boosting sporting participation among girls.

Education Minister Peter Weir was visiting St Comgall's

Primary School in Bangor to see at first hand pupils taking part in the sports initiative. The Minister commented, "Children's wellbeing is fundamentally important and central to all I do. The link between physical health and the wellbeing of young people is well-known. It is pleasing to see at first hand how this initiative helps pupils learn about mental health and wellbeing, including resilience and self-esteem.

"I recognise the contribution sport makes, not only in terms of its physical benefits, but also in raising the confidence of young people. That is why my Department has invested significantly in sports coaching provided by Ulster GAA and the IFA to support PE in primary schools."



During the visit, coaches also showcased how physical activity could be delivered in the current climate.

The Minister concluded, "This programme helps to strengthen and deepen the delivery of the

PE curriculum and introduces children to new sports and skills as they approach the transition to post-primary school."

Sport Uniting Communities BAME programme

Seven different countries were represented by participants on this year's BAME programme, organised by Sport Uniting Communities (SUC). SUC, which is run by Ulster GAA alongside the Irish FA and Ulster Rugby, launched the programme in collaboration with Multi Ethnic Sport and Culture NI (MSCNI).

The project, which aims to work with Black, Asian and Minority Ethnic communities in order to increase participation, break down barriers and provide education and opportunities in local sports, got up and running at Olympia Leisure Centre in Belfast before Covid-19 restrictions put it on hold.

To date, it has attracted sixteen people from seven different countries, including participants from Nigeria, Zimbabwe, Ghana and Ethiopia. Each session consisted of education and participation around the sports and cultures within Gaelic games, football and rugby, with participants having the opportunity to try the various skills involved in a friendly and welcoming atmosphere.

Jahswill Emmanuel, founder and chairperson of MSCNI, said, "It has been really great having this programme to enable our members to integrate and be educated on sports played in Northern Ireland. It was really nice to get back



onto the pitch after such a stressful few months. We thank Ryan McShane (Ulster GAA) and the guys for the set-up. Our guys really enjoyed the different sports and hopefully it encourages them to join a club to further their skills and to

integrate and build friendships in the community."

Liverpool's miracle in Istanbul



Liverpool's 2005 champions of europe.

Liverpool achieved a staggering victory over AC Milan in 2005, culminating in a penalty shoot-out to win the Champions League after amazingly coming from three goals down at half-time. On a night that has become known to fans as the 'miracle of Istanbul', Liverpool reclaimed their crown as 'kings of Europe' after overcoming a seemingly insurmountable challenge at the Ataturk Stadium in Istanbul.

The 2005 UEFA Champions League Final was the final match of the 2004-05 UEFA Champions League. The showpiece event took place on 25th May 2005. Liverpool, who had won the competition four times, were appearing in their sixth final, and their first since 1985. Milan, who had won the competition six times, were appearing in their second final in three years and tenth overall. It was the Reds' first appearance in a European Cup final in two decades and, despite defeating Juventus and Chelsea during a memorable run to the final, they went into the game as underdogs. Milan were seen by all as the favourites. Their team included many experienced players who had played in the competition previously. Liverpool's manager was Rafael Benitez. He acknowledged the perceived imbalance. "Maybe Milan are favourites, but we have confidence, and we can win," he said.

An estimated 40,000 fans followed their team to Istanbul. But, by the time the half-time whistle came, it was looking as though their trip was in vain. Paolo Maldini gave AC Milan a lead within the first minute of the match. Hernan Crespo then went on to score a double. All of which appeared to give the team an unassailable advantage. Milan added a third goal when Kaka brilliantly passed to Crespo. Then came half-time.

After some serious half-time discussions between players and manager, Liverpool managed to reinvigorate themselves. Rallying

cries from still-believing supporters helped too, providing the added impetus to hopefully tip the balance.

Liverpool substituted Dietmar Hamann in place of Steve Finnan. They also changed to a 3-5-2 formation, with Riise and Smicer on the outside edges, Alonso and Hamann as holding midfielders and Gerrard as an attacking midfielder.

Liverpool seized the advantage early on with Xabi Alonso sending the ball narrowly past Milan's right hand post. Dudek managed a save against Shevchenko's free-kick to stop Liverpool going four down. Steven Gerrard managed to provide some cheer for Liverpool, while Vladimir Smicer and Xabi Alonso fought back and brought things to a symmetrical balance, equalising.

Gerrard offered Liverpool further promise of salvation with a header from John Arne Riise's cross. This also helped to bring some life back to the team; and now the fight-back was in earnest. This was evidenced when Gennaro Gattuso pulled out all the stops to bring down Gerrard just as he was about to equalise. Dida saw off Alonso's attack, but the Spanish midfielder returned to produce the goods. Milan could only look on as their victory looked to be falling apart.

In extra time, Milan launched a fight-back. They managed to keep possession for most of the remaining half-hour and nearly scored in the final minutes. Then came the penalty shoot-outs.

Serginho and Pirlo missed Milan's first two, while Hamann and Djibril Cisse hit the button for Liverpool. Andriy Shevchenko was the third Milan player to miss a penalty, making it look like the end was both near and inevitable. Jerzy Dudek managed to see off goal attempts from Andrea Pirlo and Andriy Shevchenko in the nailbiting finish to clinch a stunning victory for Liverpool.

The city of Liverpool celebrated their victory by parading the trophy around town in an open-top double-decker bus the day after the final. They were cheered by around a million supporters. Benitez expressed his own disbelief at the stunning victory. "My problem is that I don't have words to express the things that I feel at this moment," he said.

It happened in 2005

Athletics - Asafa Powell of Jamaica sets a new 100m world record of 9.77 seconds at the Athens Olympic Stadium.

Cricket - Shane Warne becomes the first bowler to take 600 Test wickets. **Cycling** - American superstar, Lance Armstrong, won his record-setting seventh Tour de France title. He was subsequently to be stripped of all seven titles after admitting, in 2013, to the doping allegations that had been made against him over the course of his career.

GAA - In the All-Ireland Senior Football Championship, Tyrone triumphed over Kerry 1-16 to 2-10. This was Kerry's second consecutive final, but their win against Mayo in 2004 wasn't to be repeated in 2005.
