



on Wednesday 16th March 2022

Apologies were received on behalf of Jim Hanna, Jim McCaul and Jim Wilson.

Details of the previous meeting were eluded to, which included the introduction of the Licensing and Accounts Amended Legislation, both of which are planned for introduction as follows:- Accounts Regulations on 1st April 2022 with Phase 2 of the Licensing Legislation pertaining to Registered Clubs on the 6th April 2022.

The new Accounts Regulations will allow a

club to adopt a level of accountancy in line with the club turnover, which will undoubtedly help costs for a number of our smaller clubs.

With Covid infections continuing to show an alarming increase we are concerned about hosting an AGM in the immediate future. However, we have planned to provide an overview via direct mail to management committees of our members clubs.

Thankfully, the Helplines have continued to provide support for our members, as

has the increasing use of the Federation Facebook page.

We are pleased to see that our members appear to be enjoying more positive times, despite the current news of increasing infection rates.

Catering facilities provided by our member clubs also seem to be enjoying better times. Of course it's understandable that club members may feel somewhat safer in their club, being aware of fellow members and their guests eating in what may be perceived as a safer environment.

The Federation Treasurer, David Larmour, presented a financial report which was passed as a true record by Philip Mallon and Joe Patterson.

This concluded affairs of the meeting with thanks being extended to the management committee of Harland & Wolff Welders FSC for hosting the meeting and for providing the hospitality which followed.

Registration of Clubs - Phase 2

Members will be aware that Phase 1 of the licensing amendments introduced:-

- A) Removal of restrictions at Easter
- B) Removal of restrictions on late opening on Sunday
- C) Extension of drinking-up time
- D) Increase in number of authorisations for special occasions

Phase 2 being introduced on 6th April 2022 will add significantly to Phase 1.

Phase 2 of the Licensing and Registration of Clubs (Amendment) Act 2021 is scheduled to commence on 6th April. The changes coming into effect relating to registered clubs are:

Section 28 - Extension of sporting club premises

Section 34 - Major events

Section 35 - Removal of requirement for children's certificates

Section 36 - Underage functions

Section 37 - Private functions

Section 38 - Young people prohibited from bars

Section 40 - Restrictions relating to advertisements

Section 28: Sporting Clubs

This section deals with extending an area of a sporting club authorised to supply intoxicating liquor.

New Article 15A in the Clubs Order (Extension authorisations for sporting clubs) allows police to authorise, in writing, a sporting club to extend the area of its premises which is registered to supply intoxicating liquor for the purpose of holding a function.

The function must be likely to attract more people than could be accommodated in the registered club premises, and the application to the police

must include a plan showing the area of the proposed extension.

The extended area will be treated as part of the registered club premises for the duration of the authorisation and therefore the function will be subject to the conditions set out in Article 30 (Functions in registered clubs) of the Licensing Order.

No more than 6 authorisations may be granted in any year. An authorisation may exceed 1 day only in exceptional circumstances, determined by the police, and must not exceed 5 days.

Section 34: Major Events

This section adds a new Article 26A to the Clubs Order which gives the Department the power to make a "major event order" which will:

- designate an event, held in NI, as a major event; and
- specify the permitted hours for the sale supply of intoxicating liquor, outside of what is currently available under the Clubs Order.

The period specified in a major event order may not include Christmas Day.

The Department must consult with appropriate persons. These persons may vary depending on the event however examples would be the police and council local to where the event is taking place.

The Department may also impose conditions for the supply of intoxicating liquor in any major event order. Failure to comply may result in a fine of up to £1,000 on summary conviction.

The Department is currently developing a framework for the processing of major event orders which will be made available at the earliest opportunity.

Section 35: Removal of requirement for children's certificate, etc.

This section repeals Article 33 of and Schedule 5 to the Clubs Order (children's certificates) which required a registered club to hold a children's certificate if they wished young people under 18 years of age to be allowed in areas of club premises which contained a bar or are used mainly or exclusively for the consumption of intoxicating liquor.

The section makes further amendments to ensure all safeguards remain in place before young people under 18 years of age are allowed in areas of the premises which contain a bar or are used mainly or exclusively for the consumption of intoxicating liquor.

These safeguards include:

- meals, and beverages suitable for young people under 18 years of age, must be available,
- a young person must be accompanied by an adult and sit away from the bar,
- a young person must leave

the premises by 9.00pm (9.30pm if consuming a meal purchased before 9.00pm).

Section 36: Underage functions

This section relates to the suitability of a registered club to hold a function which is designed to appeal to under 18s in particular (underage functions).

A district commander, for the police district in which the club is situated, will need to be satisfied of the following conditions before authorising a function:

- that suitable arrangements are in place for securing under 18s attending the function do not have access to any other part of the premises which is used for the supply, consumption or storage of intoxicating liquor;
- each dispenser of intoxicating liquor at a bar in the part of the club premises where the function is being held are incapable of operation;
- access to any other container of intoxicating liquor is prevented.

The authorisation will specify the area in the registered club to hold the function and the duration of the function, up to 1.00am. *continued on pg 6*

A registered club must not supply or permit consumption of intoxicating liquor to anyone aged 18 or over in the area of the club authorised to hold the function.

Failure to comply with these conditions means:

- the club,
- every official in the club at the time the conditions were contravened and
- the person supplying or permitting the consumption of the intoxicating liquor, are each guilty of an offence and each liable to a fine of up to £1,000.

This section also makes changes to Article 108 of the Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985. It is now an offence for gaming machines to be made available in any part of licensed premises in which an underage function is being held.

Section 37: Private functions

This section amends Article 32 of the Clubs Order (young persons prohibited from bars) which relates to under 18s in part of club premises which contain a bar or is used exclusively or mainly for the supply, consumption or storage of intoxicating liquor. Under 18s will be able to remain on club premises after 9pm (or 10pm if in sporting club premises), to attend a private function, provided certain conditions are met.

The conditions are:

- the private function is held in a part of the club premises where other members, or guests of other members, do not have access to that part of the club for the duration of the function;
- the person under 18 is in the company either of a parent or of a parent of another person who is under 18 and attending the function;

- at least a main meal is being served at the function; and
- the person under 18 does not consume any part of that meal at a counter or structure that is being used wholly or mainly as a bar.

NB: "parent" includes any individual who has parental responsibility for that person or has care of that person.

Section 38: Young people prohibited from bars

This section amends Article 32 of the Clubs Order (young persons prohibited from bars). It extends the last time that young people under 18 years of age may be in the bar area of sporting club premises from 10.00pm to 11.00pm during the summer months (1 May to 30 September).

New Article 32(13A) further allows a young person to remain in the bar area of a sporting club premises until 11.00pm at any time of the year, up to

3 times per calendar year, to attend a prize-giving ceremony.

Section 40: Restrictions relating to advertisements

This section amends Article 38 of the Clubs Order (restrictions on advertisements relating to functions in clubs) which restricts advertising to solely within club premises unless the function was for sport, game or other physical recreation.

Clubs are now permitted to advertise any function outside of club premises provided, where appropriate, the advertisement clearly states that only members of the club and their guests may attend the function. It is important to note that the statement must be clearly visible on the advertisement.

Advertisements relating to functions where the proceeds are devoted to charitable or benevolent purposes will not be required to include such a statement.

Payroll changes coming into effect in April

From April this year, we'll see some changes to National Living Wage (NLW) and National Minimum Wage (NMW), as well as some updates to the process for certain right to work checks.

Here's what you need to know

NLW/NMW increases

The Chancellor confirmed in the Autumn Budget last October that the government had accepted the recommendations of the Low Pay Commission to increase the National Living Wage (payable from age 23) by 6.6% from £8.91 to £9.50 per hour.

This increase will apply to the first complete pay period from 1st April 2022 along with a range of other increases:

- increased rate for 21-22 year-olds by 9.8%, from £8.36 to £9.18ph
- increased rate for 18-20-year-olds by 4.1%, from £6.56 to £6.83ph
- increased rate for 16-17-year-olds by 4.1%, from £4.62 to £4.81ph
- increased rate for apprentices (under 19 or in first year) by 11.9%, from £4.30 to £4.81ph
- increased accommodation offset rate by 4.1%, from £8.36 to £8.70ph

Increase to Lower Earnings Limits (LEL)

In the tax year of 2022/23, there's also going to be an increase to the Lower Earnings Limits (LEL). This impacts on eligibility for

things like Statutory Maternity Pay (SMP). An employee will now need to earn at least £123 per week - up from £120 - in the eight weeks leading up to the qualifying week.

Right to work checks

Since 2018, it's been possible for employers to check details online of some people's right to work in the UK, including the type of work they're allowed to do and how long they can work in the UK. This is an alternative to manually checking their original documents, but this online service only supports some immigration statuses, like where someone has status under the EU settlement scheme.

From 6th April 2022, an Identification Document Validation Technology service will also be available, which can be used for those who can't be checked through the Home Office online service - including British and Irish citizens. These checks must be done through service providers who are independently certified as accredited assessors.

As well as this, from 6th April employers won't be allowed to carry out manual checks on certain documents anymore - including a biometric residence permit, a biometric residence card, and a Frontier Workers Permit. Instead, you'll have to check these using the Home Office's online service.

The Registration of Clubs (Accounts) Regulations (Northern Ireland) 2022

Section 12 of the Licensing and Registration of Clubs (Amendment) Act (Northern Ireland) 2011 amends Article 40 of the Registration of Clubs (Northern Ireland) Order 1996 and came into operation on 1st April 2022. The associated clubs accounts regulations were made on 10th March 2022 and they also came into operation on 1st April 2022.

The Registration of Clubs (Accounts) Regulations (Northern Ireland) 2022 revokes the Registration of Clubs (Accounts) Regulations (Northern Ireland) 1997.

Q. Our committee have recently had to invite a member to a disciplinary meeting after some poor behaviour. We are a small club and don't often have to officially deal with such problems, could you let us know how we should conduct a disciplinary procedure?

A. You cannot expel or suspend a member from the club without first inviting them to a committee meeting. A suspension or permanent

expulsion can only take place once a disciplinary meeting has been held. You can also only suspend a member for a maximum of twelve months.

If the committee are of the opinion that this individual's behaviour has either broken specific club rules/bye-laws or could be judged to be prejudicial to the club's interests then they can summon this member to appear before the committee. The committee should inform them of the allegations that have been made against them when asking them to attend the disciplinary meeting.

The committee can also instruct this member to withdraw from the facilities of membership until he appears before the disciplinary meeting. It is normal that once the withdrawal takes place, a disciplinary meeting is held within two months and that at least seven days' notice of the meeting must be given to

the member in accordance with the club's rules. If this is how the committee wishes to proceed you should write to the member and inform them that due to their conduct he has been requested to appear in front of the committee. You should also include the precise details of the complaint and alleged conduct which has forced the committee to summon the member to them. You should then hold the disciplinary meeting and, after reviewing any points this member has to make in their defence, the committee should decide if their conduct requires a suspension of membership up to one year in length, permanent expulsion from the club or no action taken against them.

If you decide to withdraw the facilities of membership from the member until the committee has heard the disciplinary meeting then this means that they will be unable to enter the club until the disciplinary meeting has been heard.

Q. We are slightly confused about the differences between an Annual General Meeting and a Special General Meeting. If we need both meetings, can they be held on the same night? Do we need to write to every member to notify them of a General Meeting?

A. Annual General Meetings (AGM) are held each year and tend to revolve around approving the club's accounts and electing committee members and officers. The main type of motions which cannot be approved at the AGM are rule changes. Items

such as bye-laws, the setting of the club's annual subscription, honoraria payments can all also be dealt with at the club's AGM. Indeed, most items can be voted on at an AGM if they do not constitute a change of the club's existing rules. Rule changes can only be dealt with at a Special General Meeting (SGM) and this also applies to motions seeking to remove the committee from office.

The Club is not compelled to write individually to every member every time a meeting is called - a notice on the notice board is sufficient for alerting members when a General Meeting is scheduled. You can certainly hold an AGM and an SGM on the same evening and this makes practical sense on a number of levels if the club has both AGM and SGM business to deal with.

Q. Due to the pandemic, we last had our Annual General Meeting in August 2021 although our rules state that it should be held in March each year. For 2022, should we hold the meeting in August allowing a full year between meetings or March as per the Rule book?

A. The club should return to its March date for holding the AGM. Whilst this will cause a one-off shorter gap than usual between AGMs, this will ensure you comply with the rules and will mean that in future years the AGM can be held as normal in March.

Morton was also instrumental in the transition of Distillery to the New Grosvenor Stadium, where, appropriately, a stand bears his name.


H&W Welders host Cheques for Charity Night

Energy update & cost saving exercises

Following on from last month, unfortunately, there is still no good news to report regarding electricity and gas prices and it seems that this will be the case for the foreseeable future. The 'forward curve' (ie. forecasted wholesale costs) would indicate that we won't see any significant dip in prices until springtime 2023.

Nigel chats with Dusty Haggan and Merv Crawford



Nigel Blair, Belfast 89FM.

It gives me the greatest pleasure to share the interview I recently held with Dusty Haggan & Merv Crawford, for decades two of my musical heroes.

Having interviewed Dusty Haggan at Belfast 89FM regarding his experiences as a vocalist with famed Belfast band, Penny Feather, he agreed to return to give me further insight on his career within the music business. I was delighted when making the return arrangements to hear that he would be accompanied by legendary saxophonist Merv Crawford, who formed the band Apartment in which Dusty also spent some memorable years.

I have to point out that both men are extremely funny, bouncing off each other's comments and generally lighting up a room with their presence.

Dusty first took to the stage at the age of sixteen being asked to sing a song with the resident band at a social club in east Belfast. He recalled, "I sang a song, All or Nothing, receiving a good response. I was

approached by a few lads in the audience who asked if I would like to join their band called Reaction. I agreed, and spent many a happy hour singing in the local club scene.

"As I gained confidence, I appeared on the cabaret circuit. At eighteen I was asked to appear in cabaret on tour in Scotland, which was successful and a good experience. On my return I would continue in cabaret. I read an advertisement in the Belfast Telegraph seeking a vocalist for a band called Penny Feather. I auditioned, singing three songs - You Lost That Loving Feeling, Get Real, and Homeward Bound. I got the job and joined the band three weeks later. We performed in the Pound Club three times a week and also featured on television and radio North and South. They were very memorable happy times.

"I also appeared in other bands along the way, such as Spring Showband, Duno, to name a few. Around 1983 I was asked to join Apartment, a band formed by Merv Crawford. Merv saw me playing in the Pound, when he called in occasionally after his own gigs."

Merv said, "I was walking up a street one night and this old boy was lying in the gutter. Realising it was Dusty, I thought I better look after this old chap." Dusty replied, not wanting to spoil the joke, "I may have been in the gutter, but gazing at the stars old boy." The studio erupted in laughter."

Merv Crawford remembers clearly taking part in a school

production with some friends. He said, "Our woodwork teacher told us to make imitation microphones and mime; we actually sang a Beatles number. Afterwards, the boys wanted to start a band. I said you can't play anything but they knew I played guitar and were hoping I would teach them. That was the formation of Just Five. As we progressed, I went into town with the boys one Saturday to the music store where I arranged the purchase of an amp we could all plug in to. I told the boys it would cost us 16 shillings a month. Five suddenly became three, and two new members were recruited. We would play the Maritime Ballroom, and similar venues.

"In 69 I stopped the music. I got married and wanted to spend more time with my wife. I started a business and was very successful. In 81 my old friend, Joe Hanratty, said I should form a new band. I formed Apartment, which was very successful, with Dusty joining us in 83. We did the Linenhall, and resident in the Errigle. We did many spots live on the BBC, some played on your show today. There were many other

bands I played in along the way, The Bank Robbers; a nine piece band called Soul Foundation. I toured in support to Ian Dury and the Blockheads, with Dino and the Dolphins. Dury's sax player would watch me on stage, and later asked me to teach him various pieces in my style. There are others too numerous to mention. I've played with the best, and loved every minute of it."

After Apartment, Dusty formed the Dusty Haggan Band, and to this day sings like a bird, one of the best male vocalist I have witnessed in my fifty years in the business. He says his style is Jazz Funk, west coast style. It will do me any day. Merv, saxophonist second to none and great stage performer, can be found plying his trade in various formats, Apartment B, and very much in demand as a session player who describes his music as Soul.

These guys are two of the very best in their field.

Thank you Dusty and Merv! Long may you continue.


